**Guidelines for the proceedings**

Practical Information

- The deadline for contributions to the proceedings is set for **December 31, 2009**.
- All contributions should be sent to **firstmillenniumprague@gmail.com** or by mail to Filip Coppens, Czech Institute of Egyptology, Charles University in Prague, Nam. Jana Palacha 2, 116 38 Prague 1, Czech Republic.
- The publication of the proceedings is set for the winter of 2010–2011.

Text

- MSWord, preferable font Times New Roman, font size 12 (size 10 for endnotes).
- When using uncommon fonts, please contact the editors in advance.
- Do not number the pages of your document.
- Tables: please do not insert the tables (or illustrations – see further) into the text, but mark its preferred position in the body of the text. Please provide each table as a separate document and add a list with captions for the tables.

Endnotes

- Please use “**endnotes**” instead of “footnotes”.
- Insert endnotes after punctuation.
- Automatically number endnotes.
- Please keep the information in the endnotes as much as possible limited to references. Argumentations should be part of the main body of the text.
- The desired format for the endnotes is: “Name, year, pages”: Gutbub, 1973, 21-25.
- In case when referring to works published by the same author in the same year, please add “a”, “b”,... to the year of publication: Badawy, 1975a, 12-45; Badawy, 1975b, 4-6;...

## Bibliography

- Please add a list of all references at the end of the paper.
- Abbreviations of journals and series according to LÄ VII.

- Please add a document with the captions for all illustrations.
